## **Conditions of the priority registration of domain names in .ҚАЗ domain.**

### **STEP 1**

#### **Priority registration of the special-purpose domain names, those for government agencies' and Presidential administration's needs, and those for Registry's technical needs.**

#### **1. General conditions**

- 1.1 To protect the interests of public authorities of the Republic of Kazakhstan and other government agencies on the Internet by reservation of the second-level domain names in the domain .ҚАЗ using the Kazakh alphabet characters.
- 1.2 Reservation of the special-purpose domain names MEM.ҚАЗ, БИЛ.ҚАЗ, КОМ.ҚАЗ, ҚАУ.ҚАЗ, ҚОР.ҚАЗ, БАЙ.ҚАЗ is carried out by Registry.
- 1.3 According to the authorized agency's list, registration of domain names for government agencies' and Presidential administration's needs is carried out by the Registrar "National information technologies" JSC.
- 1.4 Applications for reservation of domain names for government agencies' and Presidential administration's needs are accepted during the period from April 1, 2012 to April 30, 2012.
- 1.5 Domain name registration for government agencies' and Presidential administration's needs is carried out after the receipt of a timely application and copies of documents confirming the identity of the organization of public authorities.

#### **2. Procedure for reservation of domain names for government agencies' and Presidential administration's needs**

- 2.1 To reserve second-level domain name in the domain .ҚАЗ, government agencies and Presidential administration of the Republic of Kazakhstan send to "National information technologies" JSC application in the prescribed form in accordance with the appendix to the Rules for registration, use and allocation of domain space of the Kazakhstan segment of Internet. The application may be sent by fax, e-mail or regular mail, copies of the documents confirming the identity of the organization of

public authorities are attached to the application.

- 2.2 As a result of the application, "National information technologies" JSC carries out the specified domain name reservation and notify the applicant or provide a written reasoned refusal.

## **STEP 2**

### **Priority registration of domain names for holders of trademarks, logotypes and brand names**

#### **1. General conditions**

- 1.1 Registration of domain names for holders of trademarks, logotypes and brand names is carried out by the accredited Registrars.
- 1.2 To register a domain name during Priority Registration Registrar shall perform the following steps:
- 1.2.1 check the user's right for priority registration of the domain name;
  - 1.2.2 entry of the information for domain name registration to the domain names registry.

#### **2 Conditions of priority registration**

- 2.1 Priority registration is carried out in respect of the domain name that corresponds to writing a verbal designation of a trade mark registered in respect of any goods and services containing characters admissible in a domain name, when the following requirements are met:
- 2.1.1 A trademark must be registered no later than December 31, 2011
  - 2.2.2 A registered domain name should:
    - contain Kazakh alphabet characters (Cyrillic (Kazakh), the code for ISO "kk");
    - meet the requirements of the domain name, which may be registered in accordance with the Rules for registration, use and allocation of domain space of the Kazakhstan segment of Internet.
    - fully reproduce the verbal designation of a trademark or coincide with the verbal designation of a trademark after the removal of a gap or replacing spaces with hyphens, or abbreviated name of the organization, if the name includes more than two words (the first letters of the name of the organization).
- 2.2 In the presence of two or more applications for priority registration of the same domain name positive decision is made in favor of the user who previously complied with the conditions of priority registration and fulfilled the conditions of the contract with the Registrar.

#### **3 Order of priority registration**

- 3.1 Priority registration is carried out by Registrars in accordance with the Rules for registration, use and allocation of domain space of the Kazakhstan

segment of Internet and hereof.

3.2 To register a domain name an applicant must:

3.2.1 Direct to the registrar an application for priority registration of the domain name in accordance with the appendix to the Rules for registration, use and allocation of domain space of the Kazakhstan segment of Internet;

3.2.2 Provide to the Registrar a notarized copy of the following documents no more than six (6) months old:

- certificate or an international certificate of a trademark or brand registration

- certificate of state registration of legal entity, or proof of registration of the user as a legal entity, issued in accordance with the requirements of the country of registration (for foreign entities).

3.3 The documents referred to in Section 3.2, in the form of hard copies should be submitted to the Registrar not later than the end of this phase of priority registration.

3.4 Upon receipt of the application of the applicant, registrar shall perform the following steps:

3.4.1 to verify the information and documents provided by the applicant and verify that the applicant is entitled to register a domain name on a priority basis;

3.4.2 to register the domain name if the applicant has the right to register the domain name on a priority basis;

3.4.3 to inform the applicant (registrant), the results of the registration request.

3.5 Registrar shall consider the request of the applicant within 10 (ten) working days of receipt of all documents provided by Section 3.2 hereof. According to the results of the user application, the registrar shall before the expiry of the said period provide proof of registration of a domain name or provide a written denial stating the reasons.

3.6 In case of withdrawal of accreditation of the Registrar, all received documents confirming the right of priority registration of Registrant's domain name shall be transferred to the Registry.

#### **4 Cancellation of registration**

4.1 Domain name registration, carried out during the priority registration is canceled by registrar or registry in cases of violations of the conditions listed in this Conditions and (or) the unreliability of the identification information provided by the user (Registrant) in accordance with paragraph 3.2. hereof.

#### **5 Terms for priority registration**

5.1 Applications for priority registration of domain names are taken from May 1, 2012 to July 31, 2012, inclusive.

## **6 Prices for priority registration**

6.1 The cost of a domain name registration during Priority Registration, followed by support for 1 year is 7500 (seven thousand five hundred) tenge for each registered name, and charged by Registrar only in case of a successful domain name registration in the Registry. The cost of Registry Services is 3 (three) thousand tenge. Further support for the renewal of the domain name in the registry shall be operated in accordance with the conditions of the open phase of the domain names registration.

### **STEP 3**

## **Open registration of second level domain names and special-purpose domain names**

### **3.1 General conditions**

1.1 At this stage an open registration of second level domain names and special-purpose domain names is carried out for everyone in accordance with the Rules for registration, use and allocation of domain space of the Kazakhstan segment of Internet.

1.2 Open registration is carried out by Registrars on the basis of the Rules for registration, use and allocation of domain space of the Kazakhstan segment of Internet and hereof.

### **3.2 Conditions of open registration**

2.1 Open registration begins with the August 15, 2012 and made among all wishing to register a domain name in .kaz domain.

2.2 The registered domain name must:

- contain Kazakh alphabet characters (Cyrillic (Kazakh), the code for ISO "kk");
- meet the requirements of the domain name, which may be registered in accordance with the Rules for registration, use and allocation of domain space of the Kazakhstan segment of Internet.

### **3.3 Prices for open registration**

3.1 The cost of a domain name registration for the registrants during period of open registration, and followed by support for 1 year is determined by the registrars in accordance with their pricing policy.
